





DIRECTLY INFLUENCE HOW ATA ADDRESSES ISSUES AFFECTING YOUR BUSINESS

Share your voice on important issues and influence the trucking industry by getting involved in our policy committees. ATA Committees are open to all ATA members and provide a variety of opportunities to confront issues, develop solutions, and make meaningful contributions to the future success of the trucking industry. Our members set ATA's position on key industry issues, and through their direction and involvement at the Committee level, we ensure that ATA makes a difference in Washington, at the state level, and in the courtrooms.

AUTOMATED TRUCK SUBCOMMITTEE

Develops and recommends ATA policy positions related to the regulation of automated truck and platooning technologies at the state and federal government levels. Reports to the Technology and Engineering Policy Committee.

COMMUNICATIONS AND IMAGE POLICY COMMITTEE

Works with ATA staff to improve the image of the trucking industry and enhance ATA's communications with its members, media, public officials and the general public.

CONTROLLED SUBSTANCES AND DRIVER HEALTH AND WELLNESS SUBCOMMITTEE

Advises the ATA Safety Policy Committee and ATA staff on real world impacts of marijuana legalization trends, other controlled substance-related trends, and driver health trends on the trucking industry.

DIVERSITY WORKING GROUP

Provides a forum for ATA members to recommend best practices to diversify workforces. Advises the Workforce Development and Labor Policy Committee on diversity, equity, and inclusion issues.

ENVIRONMENTAL AND ENERGY POLICY COMMITTEE

Directs ATA's activities on environmental and energy matters including sustainability, air pollution rules, vehicle emission standards, anti-idling and diesel engine retrofit measures, fuel standards, hazardous waste issues, storm water and vehicle washing requirements, fuel storage, and energy efficiency improvements. This committee is currently involved in overall energy policies, alternative fuel strategies, and electrification discussions with state and federal governments to OEM's.

HAZARDOUS MATERIALS POLICY COMMITTEE

Helps ATA develop policy governing the transportation of hazardous materials.

HIGHWAY POLICY COMMITTEE

Considers and recommends policies and actions on all issues relating to highways and bridges, and issues that impact the efficient movement of commercial truck traffic on the nation's highways.



INDEPENDENT CONTRACTOR POLICY COMMITTEE

Recommends the development, advocacy, and implementation of strategies and solutions to protect the independent contractor truck driver workforce model. The committee manages the issues that develop nationally and helps to formulate a cohesive national independent contractor protection strategy.

LEGAL REFORM ADVISORY COMMITTEE

Addresses the highway accident litigation crisis and other forms of lawsuit abuse. The Committee's mission extends to the development of education and training programs, federal and state legislation, image initiatives, and fundraising to support legal reform efforts financially.

SAFETY POLICY COMMITTEE

Responsible for developing ATA policy on driver, carrier and occupational safety and health issues. The current agenda includes, among other issues, hours of service, electronic logging devices, CDL testing, improvements to the drug testing and medical certification programs, speed-related initiatives, and CSA reforms.

SMALL CARRIERS COMMITTEE

The mission of the SCC is to focus ATA leadership and staff on the needs, attitudes, influence, and political strengths of the ATA small carrier constituency; to recognize the importance of small carriers to ATA and the trucking industry in general; and, to identify and advance issues, programs, and services that will assist small carriers. Open to all carriers with less than \$27.5 million in revenue.

SUPPLY CHAIN SECURITY POLICY COMMITTEE

Acts as ATA's clearinghouse for all strategies related to the Department of Homeland Security and related agencies. It directs ATA's advocacy efforts on all issues pertaining to transportation



security and international trade via commercial motor vehicles. Current issues include the NAFTA border opening, customs automation, driver immigration, security background credentialing, and trusted trader programs.

TAX POLICY COMMITTEE

Develops ATA policy relating to federal and state taxes affecting the trucking industry. The Committee addresses business taxes, such as corporate income and franchise taxes, excise taxes, estate taxes, sales and use taxes and license fees. In addition, the Committee considers operating taxes such as fuel taxes, tire taxes, vehicle registration fees and heavy-vehicle use taxes.

TECHNOLOGY AND ENGINEERING POLICY COMMITTEE

Develops and recommends ATA policy on issues related to vehicle engineering and design, intelligent transportation systems, information technology and related topics. The Committee oversees the efforts of ATA staff in these areas as they respond to federal government legislation, rulemakings and other actions.

WORKFORCE DEVELOPMENT POLICY COMMITTEE

Responsible for efforts to increase the number of professional truck drivers and thereby decrease the driver shortage and other industry workforce needs. Works to inform on training models such as the ATA Registered Apprenticeship Program. Is responsible for considering and recommending policies and actions related to labor and employment within the industry.

AGRICULTURAL & FOOD TRANSPORTERS CONFERENCE (AFTC)

AFTC is the national organization representing commercial transporters of agricultural commodities, food, forest products and natural resources. AFTC's mission is to increase the safety, security, profitability, and efficiency of its members, and to advocate on their behalf within ATA and before the government, external organizations, and the public.



AUTOMOBILE CARRIERS CONFERENCE (ACC)

ACC represents and advocates for motor carriers engaged in the transportation of motor vehicles, including heavy duty trucks, and the suppliers serving this industry segment. ACC provides a forum for members to collectively discuss the issues affecting this specialized field and identify solutions to overcome challenges. Additionally, ACC works with automobile manufacturers to identify and establish best practices.
